



Memorandum of Understanding

This Memorandum of Understanding is between:

1. The Barbara Cappochin Foundation of Selvazzano Dentro, Vegri Street N°33/a, Padua, Italy; and
 2. The International Union of Architects (UIA), Tour Maine Montparnasse - BP 158, 33 Avenue du Maine 75755 Paris Cedex 15 France (the Partner)
- A. The Barbara Cappochin Foundation organises the Barbara Cappochin Biennial International Prize for Architecture. The UIA has endorsed the Prize since 2005.
 - B. The Barbara Cappochin Foundation wishes to attract architects from around the world to enter works completed between 1 July 2014 and 30 July 2017 for the Barbara Cappochin Biennial International Prize for Architecture.
 - C. For the 2017 edition of the Prize, the Barbara Cappochin Foundation wishes to work with the UIA Partner, the international body representing national architects' professional organisations, to promote the Barbara Cappochin International Prize to the national architects' organisations constituting its membership and thereby to those national organizations own practising members. (The Project)

Agreement

1. The Barbara Cappochin Foundation and the UIA Partner agree to work together in good faith on the Project.
2. The Barbara Cappochin Foundation shall:
 - a. provide all resources, materials and facilities that will be required in relation to the Barbara Cappochin International Prize, including:
 - i. collating entries;
 - ii. receiving entry fees;
 - iii. appointing the judging panels;
 - iv. organising judging panel meetings;
 - v. informing applicants of any judging decisions;
 - vi. providing to Partner any information the Barbara Cappochin Foundation considers relevant throughout the judging procedure.
 - b. The Barbara Cappochin Foundation will recognise the collaboration with the UIA by referring to the UIA in all written, printed, digital and spoken media connected with the Barbara Cappochin International Prize.

 - b. Encourage membership organisations to provide or adapt the Barbara Cappochin Foundation press releases as information relevant to the promotion of the Barbara Cappochin International Prize to the relevant specialist press in its country.
 - c. Provide or adapt the Barbara Cappochin Foundation press releases as appropriate in order to provide information about and to promote the Barbara Cappochin International Prize to the relevant specialist press in its countries of operation.
4. The parties intend that none of the provisions of this Memorandum of Understanding shall be legally binding.
